INFORMATION FOR STALLHOLDERS TOWN BEACH CHRISTMAS MARKET

- BCSA Member Stallholders to access grounds from 1430 and be in place no later than 1545.
- Casual stallholders to wait at Market Coordinator table not earlier than 1500 for position allocation. Vehicles to be left off grounds until a site is allocated.
- All food vans to have
 - Extinguisher;
 - Fire blanket;
 - Valid food permit and PL certificate and
 - Large bin positioned at front of stall.
- Please note sprinklers use grey water so be aware of contamination and do not drink. Do not drive over these either – they will be marked in white spray paint.
- Vehicles must drive at a 10km/hr maximum and use hazard lights at all times.
- Vehicle access from one point on road only – Robinson Street. Please be patient getting in and out of the area. No vehicle access through drain area. The Shire unlocks this gate at 1430 so if it is not unlocked please wait patiently on the road.
- If using power cords to power bollards they must be covered or raised above head height and safety tagged.
- Market fee is payable to the Market Coordinator on the night.
- No vehicles permitted to arrive past 1630, and no vehicles permitted to enter the grounds until 2030.
- Do not leave children unattended.
- All dogs to be on a leash and cleaned up after.
- Enjoy the Christmas Market.
