

Some of the things that we can stand back and be proud of, as a collective are; the Water Corporation Grant that Tim with the assistance of Maggie McFie worked to obtain and were successful in doing so -, thank you both. Our books are in a fantastic situation, we had budgeted for a loss this year, based in inflation and trends from last year, however we have done brilliantly with income up 1.7% and most importantly expenses down 8.3%. Our overall bank balance is up a healthy \$56.6k on last year. With a \$46.7k profit we now have money available for the next committee to put towards some great initiatives, whilst having our financial situation secured. These are wonderful results and a combination of work, from previous committees over the last five years, that have led us to this healthy position. Initiatives like streamed payments, with payments links sent through market specialised software. These were big decisions and changes and these current results and a reflection of the strength of these choices. Well done to prior committees for your efforts, they do not go unnoticed.

It is with a bit of a saddened heart that I will not be seen around Broome or our beautiful Broome market, as I am relocating to Perth. I can with confidence finish my tenure, in the position of Chair at this August AGM. I know that our market is in a great position and that the remaining committee members have the ethos of the markets following through their veins. My Mothers founding vision of a community market place that showcased the best of Broome, inclusive and diverse, lives on well and strong. Thanks to those who, like my Mother Claire Howard dedicated their time and passion for a community owned, members market; Broome Community Stallholders Association Inc.

WATER CORPORATION GRANT

In May 2023, BCSA Inc. won a grant (\$2,332) for the supply of much needed new tables, chairs and umbrellas. This includes:-

- 10 New custom printed umbrellas,
- 10 new tables.
- 40 new chairs.





STRONGER SUNDAY TRADING

Trading on a Sunday started later this season (starting in May 2023) and with some changes to the by-laws resulted in:-

- · An increase in stallholders.
- Increase in visitor numbers.
- · A more financially sustainable market.



FINANCIAL STRENGTH

Our BCSA finances are in good shape and ensures the ongoing success of the markets.

- Income is on a par with last financial year (+1.7%)
- Operating costs have been reduced (-17%)



MEMBERSHIP INCREASE

BCSA Inc. membership has started to increase again after a steady decline during the COVID years. We now have 70 members of the BCSA inc.



COMMUNITY PARTICIPATION

The BCSA Inc. has continued to encourage community participation at our markets including:-

- Entertainment on the Saturdays and evening markets including local and travelling entertainers.
- One off events including Easter and Christmas markets.






Each fibre creation is beautifully crafted by hand and designed with the intention of bringing a peaceful and unique energy to your space.

Shaye enjoys surrounding herself with other artistic creatives at the Broome Markets and continues to share her Bohemian style macrame and fibre arts with the Broome community and many travellers passing through.

What is your business name, art medium and art inspiration?

Desert Rose Dreaming is a handcrafted Macrame and fibre art business. Our art medium is cotton rope, jute and soft flowing fibres, often wool blends and rayon. My inspiration comes from the retro 70's era and often features dried flowers and raw jute in my Macrame art.

What inspired/ motivated you to start at the Broome markets? My inspiration for becoming a stall holder was to surround myself with like minded people who also create art and I enjoy interacting with other artists face to face.



Interacting with our local community is so important to me and as a stall holder trading at the markets provides my business the opportunity to showcase the unique handcrafted creations of Desert Rose Dreaming.

How do you feel the markets have given you a platform for launching your business? Being a stallholder at our local markets gives me the opportunity to show customers what Macrame art feels and looks like real life, it's a wonderful feeling when the customer asks questions about how long a piece takes to create or how many metres of rope it takes to make my wall hangings, it's a nice connection between Artist and customer.

What have been your successes?

This season has seen my small business grow from one day of trading per week to both a Saturday & Sunday trade as well as launching my online store with multiple sales shipped across Australia weekly.

What have been your goals?

My goals have been to provide top quality Macrame products with excellent stock volume throughout the busy dry seasons, I have expanded my designs and products to keep up with the demand for handcrafted goods.




